General Rules

SIDA % Days allow for practice test riding and coaching during test rides from Training to FEI levels. The 2015 Equine Canada Tests will be used along with HCBC Western Dressage, current Pony Club and Eventing tests.

Ribbons will be awarded according to:

- 1st – 60% and above**
- 2nd – 57% to 59.99%**
- 3rd – 54% to 56.9%**
- 4th – 50% to 53.9%**

Draw Reins are NOT permitted to be used at any time while on the show grounds.

Approved Headgear must be worn at all times when mounted at the grounds. Informal riding attire is permitted, boots must have heels.

Coaching is permitted during test rides.

Any test may be repeated by entering it separately for each ride on the entry form. Rides are limited to 4 per horse for the day.

Riders must be 2018 members of Horse Council BC.

Fees - \$ 20.00 per test - all levels.
